## Dr. Jonathan Parr, Assistant Professor of Medicine, Division of Infectious Disease

Dr. Parr presented to the Campus Safety Commission a general overview of the state of COVID-19 in the state of North Carolina in addition to the great Chapel Hill area. Dr. Parr referenced greater trends in cases across the country and globally that allow us to deduce possible outcomes regionally.

Dr. Parr reviewed current cases and testing protocols and efficiencies, hospitalization rates and capacity, and emphasize the need for high-yield interventions against the virus which include social distancing, routine use of face masks, and hand hygiene.
